
Following are the present scores required for the different occupations in this category.

Minimum points for Accountants is at 70, Auditors, Company Secretaries and Corporate Treasurers also require 70 points minimum while a minimum score of 65 points is required for the following occupations -ICT Business and System Analysts, Software and Applications Programmers, Computer: Network Professionals, Electronic Engineers, Industrial, Mechanical and Production Engineers as well as other engineering professionals. As for the family sponsored visa the required score remains at 60.

The present status in general

IT and Engineering professionals are now in a better position that previously with the minimum score being at 65 points. The Skill Select scheme is also back on a more predictable track which bodes well for hopeful migrants.
